

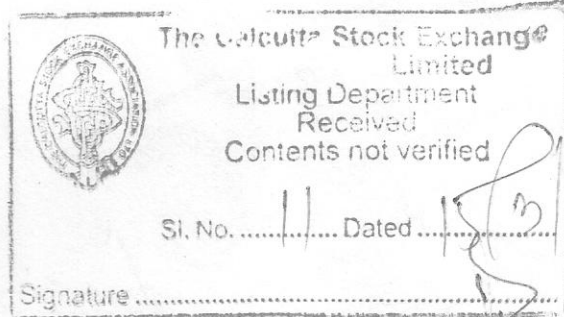

This is due to the indiscipline of the workers in the tea estate which has also created a risk of the life of the Estate Mangers and the Officers working in the said tea estate.

The tea plucking and manufacturing operations of the tea estate has ceased from today and at the present moment we are unable to ascertain how long the lockout will continue. In view of this we are unable to calculate the quantum of loss in the operations of the tea estate.

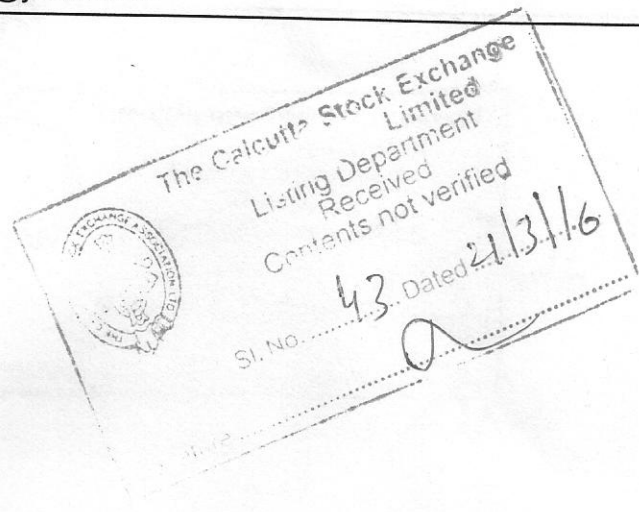
